

MINUTES OF MEETING HELD MAY 23rd, 1941, TEMPLE, TEXAS

The State Soil Conservation Board met on May 23rd, at Temple, Texas, with the following Members present: Walter W. Cardwell, Chairman, H. K. Fawcett, Wm. G. Kennedy, J. P. Martin, and C. M. Caraway.

The election returns for elections held May 10th 1941 in the proposed Eldorado Divide S. C. D., No. 212, and Upper Sabine S. C. D. No. 530, were canvassed, and more than two-thirds of the qualified voters having voted in favor of the creation of a district, a determination of practicability and feasibility was given approval by the Board.

On motion by Mr. Caraway, seconded by Mr. Martin, the Administrator was authorized to appoint two Supervisors in each of the districts, and to proceed with the completion of the districts.

Returns of elections held in 17 districts for the election of Supervisors were reviewed and declared effective on the basis of returns which are hereto attached and made a part of these minutes.

On motion by Mr. Fawcett, seconded by Mr. Martin, Mr. Paul Manning, Rt. 1 Leonard, Texas, and Mr. C. R. Stevenson, Caddo Mills, Texas, were appointed as Supervisors for S. C. D., No. 530, to serve until their successors are elected and have qualified for a regular term. The Administrator was authorized to appoint two Supervisors for S. C. D., No. 212, subject to final approval of the Board.

On motion by Mr. Fawcett, seconded by Mr. Martin, the Administrator, upon recommendation of the Supervisors and landowners, was authorized to fill vacancies occurring on the various district boards, subject to the final approval of the Board.

With a prospect of a deficiency in the fund for payment of Supervisors prior to May 20th, 1941, the Administrator was authorized that should such deficiency occur, that the funds be prorated to the Supervisors of the various Districts on the basis of time submitted for that period ending May 20th.

The services of Mr. Garlen R. Bryant as Stenotype Stenographer were terminated, as of May 20th, and he was advanced to the position of Administrative Assistant at a salary of \$2,700.00 per year, effective that date. On motion by Mr. Kennedy, seconded by Mr. Fawcett, the Board determined that the position of Administrative Assistant would be available to Mr. Bryant upon his return from the Army within a reasonable time.

Because of the necessity of appearing before the Committee of Departmental Appropriations, the Board recessed at 12 o'clock to reconvene at Austin, Texas, at 2 p.m.

Having appeared before Members of Committee during the afternoon of May 23rd and the morning of May 24th, the Board adjourned at 2:30 p.m., May 24th.
