We expect close to 700 district directors, district employees, and federal and state employees who assist districts to attend this meeting.

The Association of Texas Soil and Water Conservation Districts will provide space for small table top exhibits to a limited number of exhibitors to display goods and services that may be of interest to soil and water conservation district directors, their employees and other attendees interested in conservation.
