THE STATE SOIL CONSERVATION BOARD MET IN AUSTIN, TEXAS, ON APRIL 20, 1944, AT 9 A.M. WITH THE FOLLOWING MEMBERS PRESENT; WALTER W. CARDWELL, CHAIRMAN, C.M. CARAWAY, J.P. MARTIN AND W.M. DECK.

LOWER PEASR RIVER No. 122
UPPER PEASE No. 123

IT WAS CONSIDERED AND DETERMINED THAT THERE IS A NEED FOR THE FOLLOWING ANNEXATIONS OF ADDITIONAL TERRITORY IN THE FOLLOWING DISTRICTS, IN WHICH THERE ARE NOT MORE THAN ONE HUNDRED LAND OWNERS;

NORTH CONCHO RIVER No. 208
UPPER LEON, (BEATTIE) No. 525

THE APPOINTMENT OF SUPERVISORS IN DISTRICTS TWO AND FOUR IN KERR COUNTY WERE APPROVED.
